B. Segrera, a Spanish national and an Associate Professor in the Jawaharlal Nehru University, who was living in the Campus had not been seen during the previous few days. As there was no indication about his whereabouts. window of his bed room was got opened from outside. As foul smell starting coming out, the matter was immediately reported to the police. The police came and broke open the door of the house in the presence of University officials. Dr. Segrera was found dead on his bed, and his body was in a highly decomposed condi-The body after post-mortem examination was taken over by the Spanish Embassy and buried. The police is investigating the matter.

State-wise allocations for the year 1983-84 have not yet been finalised. Under NREP works for creation of durable community assets for strengthening the rural infrastructure, such works as irrigation, social forestry, drinking water wells, construction of rural roads, construction of groups houses/land development for SCs/ STs., village tanks, soil and water conservation and land reclamation and construction of schools and balwadis buildings and panchayat ghars etc. could be taken up by the Orissa. Government in all the districts.
