This is in progress. The current price fixed by Government for Prednisolone is Rs. 17100 per kg., for Hydrocortisone Acetate Rs. 15795 per kg and for Hydrocortisone Rs. 15423 per kg. These are the maximum sale prices. The company does not manufacture Trimethoprim and Sulphamethoxazole. The question of recovery of unintended profits, if any, into the Drug Prices Equalisation Account from M/s. Wyeth Lab., has not, therefore, arisen.
