Meanwhile fresh reports of violence have come from areas under eastern coalfields. According to Coal India Authority, one colliery workers was killed today due to a bomb blast in New Satgram colliery. Three others were injured.

Doordarshan

The news item on the strike by Coal Miners was taken only in Doordarshan's National Bulletin in English telecast on November 8, 1981. The text of the news item is reproduced below:

"Work in the Coal mines of the Jttar Pradesh, Madhya Pradesh, Central Coal fields Ltd. in Bihar, Orissa and West Bengal was reported to be normal today despite the one-day strike call given by some Trade Unions. Barring few minor incidents in Kuju and Hazaribagh areas in Bihar, no untoward incident has been reported. Attendance in all the Coal Mines in these States was around 85 per cent. In the North-Eastern Coal fields in Assam, there was cent percent attendance."

(क) डाक व तार विभाग में विभागेतर कर्मचारियों की संख्या कितनी है और वे कब से विभागेतर कर्मचारियों के रूप में कार्य कर रहे हैं ;

(ख) क्या एक ही स्थान पर तथा एक जैसा ही कार्य करने वाले एक स्थायी कर्मचारी तथा एक विभागेतर कर्मचारी के वेतन तथा अन्य सुविधाओं में कोई अन्तर है ;

(ग) क्या यह भी सच है कि विभागेतर कर्मचारी 12 से 24 वर्ष की सेवा के पश्चात् भी विभागेतर कर्मचारी ही रहते हैं और विभाग उन्हें वर्दी, जूता, छाता तथा बरसाती उपलब्ध नहीं कराता है और उन्हें बिमार पड़ने पर छुट्टी लेने का भी अधिकार नहीं है ; और

(घ) क्या सरकार इन कर्मचारियों के कल्याण के लिए कुछ करने का विचार रखती है ?
