## Posting of General Managers in J&K State

Written Answers

- SHRI DHARAM CHANDER Will the Minister of PRASHANT; COMMUNICATIONS be pleased to state:
- (a) whether it is a fact that since some time past the General Managers Telecommunications who were on verge of retirement are being posted in Jammu and Kashmir and during their short stay in the State they are incapable of getting their grip in administration and other matters; and
- (b) whether Government propose to revise this policy so that the General Managers who are posted in the State should work for a longer period so that shortfalls in this circle are removed?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI VIJAY N. PATIL): (a) It is not totally correct that only those officers of Jr. Administrative Grade who were on the verge of retirement have been posted as General Manager in the J &i K Telecom. Circle. From 1973 onwards only the last 2 officers including the present incumbent were on the verge of retirement when they were posted as General Manager in the J & K Circle. These officers have plenty of administraticve and technical experience in the telecommunication iield and hence were fully capable of getting their grip in administration and other matters. But earlier to them there were three officers as General Manager who had long innings to go in P & T.

(b) The points raised by the Hon'ble Member of Parliament will be, however, taken into account while deciding the posting of an officer as General Manager Telecom., J&K Circle in future.
