## Hydei Electric Project in Kishtwar

- \*10. SHRI DHARAM CHANDER PRASHANT: Will the Minister of ENERGY be pleased to state:
- (a) whether it is a fact that Hydel Electric Project Dul Hasti in the Kishtwar area of Jammu has been sanctioned and the preliminary work has started;
- (b) how much amount is likely to be spent on the project during 1983-84 and what is the estimated total expenditure to be incurred on this project:
- (c) by when the project is likelyto be completed phase-wise; and
- (d) how much power is likely to be generated from the Dul Hasti Power Houses phase-wise?

THE MINISTER OF ENERGY (SHRI P. SHIV SHANKAR): (a) Yes. Sir.

- (b) A provision of Rs. 2 crores has been made for the project in the budget estimated for 1983-84. The estimated cost of the project is Rs. 188.43 crores (gross) including interest during construction.
- (c) The project provides for installation of 3 generating units of 130 MW each. The first generating unit is scheduled to be commissioned by the end of 1990 and the second and third units would be commissioned at an interval of 6 months each thereafter.
- (d) The three generating units will generate 1928 Million Kwh of energy annually in a dependable year.
