- (d) Power from the Singrauli Super Thermal Power Station has been allocated for meeting the requirements of the beneficiary States in the northern region only.
- (e) The Madhya Pradesh Electricity Board has been suitably apprised of the position.

Clearance of Nathpa-Jhakri Hydel Power Project

Howeve^ investment decision has not been taken so far.
