

**Re-employed Government Officials in  
Public Sector Undertakings**

PRAJAPATI: Will the Minister of \*•  
FINANCE be pleased to state:

(a) whether it is a fact that the Prime Minister has recently issued directions regarding termination of the services of superannuated Government officials re-employed in Central public sector undertakings;

(b) what are the names of such officials serving in various Central public sector undertakings as full time Chairmen or Managing Directors; and

(c) whether services of any of these re-employed officials have been terminated and if not, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PATTABHI RAMA RAO): (a) The Prime Minister has recently issued directions that Ministries/ Departments should review the cases of officers on extension/re-employment in Government/public sector and issue orders to terminate their services by giving them the required minimum notice, except where there are any special reasons for continuing the extension/re-employment to run the full course. This does not apply to the extension/re-employment of Defence Personnel in civil posts upto the age of 58 and of scientists.

(b) and (c) According to available information the names of full-time Chairmen/Managing Directors of Central public enterprises who have crossed the age of 58 are given in the list. (*See below*). Decision on retention/termination will be taken after completion of review.
