Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) what is the policy of Government in the matter of posting and transfer of C.G.H.S. Unani physicians, Pharmacists, clerks etc.;

(b) what are the names of such staff members in Unani dispensaries in Delhi who had been working in the same dispensary for more than three years; and

(c) what action Government propose to take in the matter so that no staff member is allowed to be in the same dispensary for more than three years?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (MISS KUMUDBEN M. JOSHI): (a) Posting and transfer of C.G.H.S. staff is done according to the general policy of the Government as is applicable to the Central Government employees.

(b) The names of the C.G.H.S. Unani staff who have worked in a dispensary for more than 3 years are given below:

(c) There is only one Unani dispensary and one Unani Unit in Deihi and the staff is to be transferred between these two units only. The staff of the Unani Unit which was established on 15-10-1980 has not completed 3 years. Transfers will be effected as and when considered necessary in public interest.
