

**Villages without schools**

1369. SHRI MANOHAR JOSHI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether any survey has been conducted to identify the villages without schools;

(b) if so, the details thereof;

(c) if not, the way Government intend to address this issue and by when Government intend to conduct a survey;

(d) whether Government propose to establish at least one school in each village of the country;

(e) if so, whether any target has been fixed in this regard and any fund earmarked for the purpose; and

(f) if so, the details in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI D. PURANDESWARI): (a) to (c) National Council of Educational Research & Training (NCERT) conduct surveys from time to time regarding school education and compiles data/ statistics for use by various stake holders. As per the provisional report of the 7th All India School Education Survey (AISES) conducted by NCERT with reference date 30.9.2002, 3.74% of villages have neither primary no\* upper primary schooling facilities.

(d) to (f) The norms for Sarva Shiksha Abhiyan (SSA) provide for a primary school within one kilometer of every habitation. Upper primary schools are allowed as per requirement, based on the number of children completing primary education, up to a ceiling of one upper primary school/section for every two primary schools. 1,57,967 new schools have been sanctioned up to 2005-06 under SSA. During 2006-07, 64,418 new schools have been sanctioned so far.

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI D. PURANDESWARI): (a) Under the Innovative and Experimental Education component of Sarva Shiksha Abhiyan, the Ministry of Human Resource Development has provided funds during the last three years *i.e.* 2003-04, 2004-05 and 2005-06 to 21,19 and 30 Voluntary Organizations respectively for running innovative education projects.

(b) All districts and blocks of Uttar Pradesh and Rajasthan are covered under the Sarva Shiksha Abhiyan, a programme for universalization of Elementary Education run in partnership between Central and State Governments.
