Licences granted to Monopoly Houses

THE MINISTER OF INDUSTRY (SHRI NARAYAN DATT TIWARI): (a) 113 Industrial Licences (including 10 carry-on-business licences) were granted during 1982 to undertakings registered under the MRTP Act.

• (b) to (d) An industrial licence is

grantee with an initial validity period of two years and two extensions of one year each in suitable cases are also given. It generally takes three to four years for an industrial licence to fructify. It is, therefore, too early to state the number of utilised licences at this stage.
