- (b) if so, what are the recommendations of that team in respect of financial aid to the State Government for meeting the drought situation; and
- (c) what is the progress so far made in this regard and the amount which has been sanctioned for West Bengal to meet the serious drought situation in the State?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ARIF MOHD, KHAN); (a) Yes, Sir. A Central team visited the drought affected areas in West Bengal between the 8th and 11th November, 1982.

(b) and (c) On the basis of the report of the Central team and the recommendations of the High Level Committee on Relief, Government of India have sanctioned a ceiling of expenditure of Rs. 4950.00 lakhs and a loan of Rs. 300.00 lakhs for combating drought situation during 1982-83.

This is in addition to the ceiling of expenditure of Rs. 2477.00 lakhs sanctioned earlier on 15th September, 1982 during 1982-83.

Membership for Co-operative Societies in Delhi

- (d) if so, what are the details in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI YOGENDRA MAKWANA):
(a) to (d) The Managing Committee of a cooperative society may enrol members in accordance with the provisions of the Delhi Co-operative Societies Act, 1972, the Rules framed thereunder, the registered bye-laws of the respective society and any other direction issued to a society or class of

such societies. The details in this regard, however, differ from class to class and society to society. The verification of membership is done in accordance with the aforesaid requirements.
