- (b) As per information furnished by the National Aids Control Organisation, the known modes of transmission of HIV/AIDS from person to person are through unprotected sex with an infected person, transfusions of infected blood and from mother of child during pregnancy and child birth. The mode of transmission among injectible drug users is through sharing of needles. As per Sentinel Surveillance 2005, the HIV positivity among commercial sex workers has been found to be 8.4%, whereas in the general population, the positivity is less than 1 %. It can, therefore, be concluded that commercial sex workers are major transmitters of this disease.
- (c) and (d) The proposed amendments to the Immoral Traffic (Prevention) Act 1956, seek to prevent trafficking in women and children for prostitution by incorporating stringent punishment for traffickers who recruit, transfer, harbour or receive a person for the purpose of prostitution. The Bill was introduced in Lok Sabha on 22nd May, 2006 and is now under the examination of the Ministry related Parliamentary Standing Committee.

Swayam Siddha Scheme

No proposal is pending with Ministry of Women and Child Development as on 31.7.2006 under the Scheme of Swayam Siddha for release of funds to State Governments based on Annual Action Plans.

Funds under Balika Samridhi Yojana

Under both the schemes funds amounting to Rs. 14.37 crores and Rs. 126.79 crores respectively were made available during the last five years.
