Husbandry for the development of appropriate technology:

- 1. Southern Regional Research Station of CSWRI at Mannavanur, Kodai Kanal, Tamil Nadu.
- 2. All India Coordinated Research Project on Sheep Breeding:
 - (i) Mutton unit at the Livestock Research Station, Palamner, Andhra Pradesh.
 - (ii) Fine wool unit at the Sheep Breeding Research Station, Sandynallah, Tamil Nadu.

Another centre of All India Coordinated Research Project on Sheep Breeding for Mutton has been sanctioned during the Sixth Plan and is to be located in Karnataka.

The Government of India has also the following development programmes for increasing wool and mutton production in South India:

- 1. Large Scale Sheep Breeding Farms in Andhra Pradesh and Karnataka for producing crossbreed stud rams to be provided to Sheep Breeders.
- 2. Intensive Sheep Development Projects to provide Breading and health cover to the flocks of sheep breeders and to advise them on improved sheep management practices.

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVE-(SHRI HARI LOPMENT NATH MISHRA): (a) The number of unemployed persons in the rural areas was estimated at 15.36 millions March, 1980 on the basis of rate unemployment observed in the tional Sample Survey 32nd Round (1977-78).A-1- 1 1

- (b) About 148 million persons were working full time and about 41 million persons were working part time in rural areas as per the 32nd Round of Survey conducted by the National Sample Survey Organisation in 1977-78.
- (c) The problem of unemployment cannot be tackled by a crash programme. The employment generation depends upon the sum total of economic activity both in public and private sectors. Various schemes of Central Government and the State Governments in sectors like Agriculture, Irrigation, Animal Husbandry, Forestry and Rural Works etc. generate employment in rural areas on a continuing basis. This Ministry has also been implementing special programmes like National Rural Employment Programme (NREP), Integrated Rural Development Programme (IRDP) and Training of Rural Youth for Self-Employment (TRYSEM) for maximising the employment opportunities in areas.
