Development of Science and Technology in the Country

1450. SHRI O.T. LEPCHA: Will the Minister of SCIENCE AND TECHNOLOGY be pleased to state:

(a) the steps taken by Government for development and promotion of science and technology in the country particularly in the State of Sikkim;

(b) if so, the details thereof; and

(c) the details of funds granted for this purpose during the last three years, State-wise?

THE MINISTER OF SCIENCE AND TECHNOLOGY (SHRI KAPIL SIBAL): (a) and (b) The Government provides financial assistance for development and promotion of science and technology in the country, including the State of Sikkim under various programmes such as Science and engineering research council, Science communication, natural resource data management system, science and society, State science and technology programme, bio-technology etc. The projects approved are based on the proposals received from various institutions in the States.

In addition to these R&D projects, Government provides financial support to various State Councils for Science and Technology for development and promotion of science and technology in the respective States.

(c) The State-wise and year-wise details of funds granted for this purpose are attached as Statement-I and Statement-II.
