

### Gas Agencies for freedom fighters

614. SHRI SHANTI TYAGI: Will the Minister of ENERGY be pleased to state:

(a) whether Government have fixed up a quota of cooking gas agencies for freedom fighters in the country; and

(b) if so, how many gas agencies have been allotted to the freedom fighters or their families during this year?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI DALBIR SINGH): (a) 10 per cent of all the dealerships/distributorships to be awarded by the oil companies against their plan for the year 1981-82 are reserved for Outstanding Social Workers/Freedom Fighters.

(b) As on 31-8-1982, 26 LPG distributorships were awarded to the Social Workers/Freedom Fighters all over the country.

### Telecast of Asian Games through intelset

†615. SHRI SURESH KALMADI: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) whether Government are considering a proposal for telecasting the Asian Games with the help of the INTELSAT; and

(b) if so, what are the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI ARIF MOHAMMED KHAN): (a) Yes, Sir.

(b) A transponder of INTELSAT is being hired which will enable the telecast of the Asian Games from all the transmitters including those not connected by microwave circuits. The estimated cost of hire of INTELSAT and the consequent transmission of ground segment will be Rs. 2.30 crores with a foreign exchange component of Rs. 2.06 crores.

SALVE): (a) and (b) The Government have a proposal for expanding the Film and Television Institute of India into a Regional Centre for Asia with the assistance of UNESCO. The proposal at present is under examination in consultation with the UNESCO.

श्री रामेश्वर सिंह : श्रीमन्, पहले हमारा व्यवस्था का प्रश्न सुन लीजिए। आप हर बात को टालते जा रहे हैं... (व्यवधान)।

श्री उपसभापति : आप किस नियम के अन्दर यह व्यवस्था का प्रश्न उठा रहे हैं। नियम का उल्लेख कीजिए।

श्री रामेश्वर सिंह : नियम आप देख लीजिए ... (व्यवधान)

श्री उपसभापति :

You have to raise a point of order according to the rules. What point of order are you raising? आप इस तरह से धमकी मत दीजिए। आप व्यवस्था के प्रश्न पर धमकी क्यों देते हैं ?

श्री रामेश्वर सिंह : धमकी इसलिए देते हैं कि आप मदन को ठोक से नहीं चलाते हैं ... (व्यवधान)। मैं बिलकुल समझ से और जिम्मेदारी के साथ कह रहा हूँ।

श्री उपसभापति : यह व्यवस्था का प्रश्न उठाने का तरीका नहीं है ... (व्यवधान)।

श्री उपसभापति : क्या आप 8 ही मिनट बोलें ?

श्री सत्यपाल मलिक : 8 मिनट भी आप बोलने की इजाजत नहीं देते हैं। मेरे सवाल रिकार्ड में नहीं आए। 7 मिनट में मैं सवाल करना शुरू कर देता हूँ, लेकिन मेरे सवाल प्रोसीडिंग में नहीं आते ... (व्यवधान)। आप नियम के अनुसार यह नहीं करते हैं। मैं जानना चाहता हूँ कि 8 मिनट के बाद मेरे सवाल प्रोसीडिंग में क्यों रिकार्ड नहीं किए गए ?
