MR. DEPUTY CHAIRMAN: Are there still some points left?

SHRI C. P. N. SINGH: I have got every point noted...

SHRI PILOO MODY: He must answer all the questions. He is doing well. Let him do.

SHRI C. P. N. SINGH: Regarding doctors abroad, it is quite true that a number of doctors—I do not know the exact number, the Member has put it at 15000—are involved. We must realise that the facilities and advantages that we have in our country are not as developed as, say, in the West. These doctors who have gone out of the country, if they return—the majority to return—it is an advantage, because they are exposed to facilities, to research which is not available in India. So they come back with more knowledge, more experience, with the latest techniques and innovations and they now have the facility of importing equipment, getting equipment which will help thousands and thousands of people in India who are deprived of that kind of medical attention.

The last point was regarding the Gajendragadkar Committee. But this was along with the other suggestions that the honourable Member has given. I assure the honourable Member that we will have all the suggestions looked into with all seriousness, and I do hope the honourable Member next time will not be as discouraged as he is today regarding frustration in the scientific community.

DR BHAI MAHAVIR: One small thing. Will he consider the difficulties which presently the scientists suffer from because the CSIR is a registered society and therefore, is beyond the surveillance of Parliament as well as courts. When every penny spent on it is coming from the public exchequer, why should the scientists not have the protection of Parliamentary scrutiny and judicial review?

SHRI C P- N. SINGH: This is a suggestion by the honourable Member. I cannot give any assurance. We will first look into what the honourable Member has said, and see what is feasible.

DR, BHAI MAHAVIR: Please consider it.

MR. DEPUTY CHAIRMAN: The discussion will continue after lunch.
