### **Private public partnership financing of**

#### **infrastructure projects**

1554. SHRI RAJEEV CHANDRA SEKHAR: Will the Minister of FINANCE be pleased to state:

- (a) what is the total cumulative net quantum of FDI (excluding FN) into various Infrastructure projects since May, 2004;
- (b) what is the status of the private-public partnership financing of infrastructure projects;
- (c) if so, how many projects have been approved under this programme;
- (d) what is the total quantum involved and the details of these projects; and
- (e) how many projects under private-public partnership are being considered for financing from Karnataka?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PAWAN KUMAR BANSAL): (a) Sector-wise FDI inflows during 2004 (January-December), 2005 (January-December) and 2006 (January-March) including that of infrastructure sectors, is given at Statement-I (See below).

(b) to (e) For those Public Private Partnership projects in infrastructure sector, which are commercially not viable but have a high economic value, the Government of India had announced the scheme of Viability Gap Funding (VGF) in August, 2005. The scheme covers only those PPP projects in the infrastructure sector, which are to be implemented by a private entity that is selected through a competitive and transparent bidding process. The status of the proposals received so far under this scheme is at Statement-II.

**Improvement of customer services in Banks**

1555. SHRI B.K. HARIPRASAD: Will the Minister of FINANCE be pleased to state:

(a) whether to improve customer services in Public Sector Banks, the RBI has constituted Banking Codes and Standards Board of India and if so, how many Public Sector Banks have signed the charter so far with the BCSBI;

(b) whether it will be mandatory to all constituents of Indian Banks Association to subscribed to this charter;

(c) whether the functions for the BCSBI will overlap with that of the Office of Banking Ombudsman Scheme; and

(d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PAWAN KUMAR BANSAL): (a) Yes, Sir. The Banking Codes and Standards Board of India (BCSBI) has been set up by Reserve Bank of India (RBI) for improving the quality of customer service in banks BCSBI has been registered as a Society. As on date, 24 Public Sector Banks including State Bank of India have been registered with BCSBI.
