categories which are not covered by normal airlines practices who *have* been issued free passea/incentive tickets to travel by Indian Airlines and Air India;

- (b) what are the reasons for issuing free passes/incentive tickets in each case; and
- (c) what has been the monthly loss of revenue due to issuing of such free passes/incentive tickets (month-wise) from January 1980 to September 1982?

THE MINISTER OF STATE IN THE MINISTRIES OF CIVIL AVIATION AND CIVIL SUPPLIES (SHRI BHAGWAT JHA AZAD): (a) Indian Airlines and Air India issue free passes/ incentive tickets in conformity with airline practices.

- (b) The main reasons are promotion of commercial interests, publicity, charity etc.
- (c) As the issue of the passes/in centive tickets is in the commercial interest of Air India with the view to increase its revenue, there has been no loss of revenue.

Remoyal of Garbage Dumps Near Palam Airport

Hijacking of Plane*

1777. SHRIMATI MANORAMA PANDEY:

SHRI RAMANAND YADAV:

Will the Minister of CIVIL AVIATION be pleased to state:

- (a) whether it i_s afact that in the recent past several attempts were made to hijack the Indian Airlines planes; and
- (b) if so, what measures have been taken by Government to prevent hijacking of planes?

THE MINISTER OF STATE IN THE MINISTRIES OF CIVIL AVIATION AND CIVIL SUPPLIES (SHRI BHAGWAT JHA AZAD); (a) Ye_s Sir. During the last two years, three aeroplanes of Indian Airlines were hijacked.

(b) Several steps have been taken to prevent hijacking of aircraft in the country. These include; (1) installation of sophisticated electronic equipments like Door Frame Metal Detector, Hand Held Metal Detector and X-Ray Baggage Inspection System at various airports. (ii) on-the-job training of security stalf (ill) increased surveillance at the airports (iv) strict control on entry into operational areas (v) guarding of aircraft by armed contingents- (vi) strict ladder point checks of passengers and (vii) dummy checks by senior officers to test the efficiency and alertness of the security staff.

Welfare of Scheduled Castes/Scheduled Tribes
