their houses having been washed away by the recent floods in Bani District in Orissa; and

(b) if so, what is the number and what measures Government propose to take to rehabilitate them?

THE MINISTER OF STATE IN THE MINISTRY OF IRRIGATION (SHRI Z. R. ANSARI): (a) and (b) The State Government has reported that one lakh houses were washed away by floods in 1982 in the State as a whole District-wise details of which have not been furnished by the State Government. All efforts are being made by the State Government to rehabilitate them. Central team have also recommended some specific amount for rehabilitation to be earmarked out of the Central assistance provided for relief work.

Construction of Salal Hydel Project

(c) Earlier it was scheduled for commissioning in 1987. Recently the Ministry of Energy took steps to cut short the period of commissioning and now the schedule is as follows:
