Uniform Marriage Law

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS -(SHRI P. VENKATASUBBAIAH) : (a) Yes, Sir.

(b) The policy of the Government is not to effect any changes in the personal Laws of the minority communities unless the initiative for reform comes from those communities.

Development of a part at Shanti Niketan Colony

(b) whether the Park in question has not as yet been developed properly, wild bushes and . stone boulders surround it and there is no proper fencing to prevent stray cattle entering into it and above all there exists a wild thorny tree, which too has not been removed ; ' and

(c) if *o, what action Government propose to take to develop it properly and afford necessary relief \cdot to the residents who pay high taxes to the M.C.D. ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P.. VENKATASUBBAIAH) : (a) to (c) The Municipal Corporation of Delhi have reported that while it is a fact that the park has not as yet been fully developed, but there is no wild growth inside it. The Park is duly fenced and the stone boulders have also been removed. The tree referred to in the question is healthy, green and not worth cutting. It has been explained that the park has not been fully developed for want of adequate irrigation water. This and other parks in the colony are being irrigated by tubewells owned by the Housing Cooperative Society of the colony who are unable to augment the water supply for irrigation purposes. The park will be further developed as soon as the water supply position eases.
