THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI JANARDHANA POOJARY); (a) and (b) A letter dated 24-7.1982 was received by the Finance Minister from a Member of Parliament. Allegations of mismanagement and corruption have been levelled against the management of the company which has been taken over under the provisions of the Industries (Development and Regulation) Act, 1951. Allegations of lack of control by the Industrial Reconstruction Corporation of India Ltd. (IRCI), Calcutta which has been appointed as the 'authorised person' have also been levelled. A demand has been made for investigation by an outside team into the performance of the company and to examine the extent to which the IRCI was responsible for the state of affairs of the company.

- (c) and (d) The factual position in regard to the allegations against the management of the company and IRCI Ls being ascertained by the Government and further course of action will be decided after the factual position is known.
- (e) During the year 1982 (January—September), IRCI has disbursed Rs. 27.99 lakhs by way of term loans to M/s. Bengal Potteries Ltd.
