No incident of kid. napping of Indian_s or looting of Indian property ha_s taken place in thi_s area during this period.

(e) Adsquate arrangements exist to safeguard the Line of Control in J&K. Whereas major instances of violation are taken up with the Government of Pakistan, minor incidents ore attempted to *be* resolved periodically by holding Flag Meetings of local Com. manders.
