

tion. Under the Krishi Vigyan Kendra for Scheduled Castes/Scheduled Tribes, 15 such Kendras will be set up in selected districts having Scheduled Castes and Scheduled Tribes concentration. These Kendras will impart vocational training to these communities in the field of agriculture and allied areas. Under another scheme included in the Sixth Five Year Plan, the ICAR provides post-matric scholarships for Scheduled Castes and Scheduled Tribes candidates for undergoing education in agriculture and allied sciences. The ICAR has also made provision for reservation of 20 per cent seats for senior and junior fellowships for Scheduled CasteS/Scheduled Tribes candidates.

(d) The programmes of the Department of Agriculture and Cooperation are generally area-based and not beneficiary-oriented. Hence, information on the number of beneficiaries including the Scheduled Caste, families is not available.
