(b) The British Government is aware of the sentiments of the Sikh community both in India and in the U.K. However, the Government of India cannot interfere in the judicial processes of another country.

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI A. A. RAHIM): (a) Government of India are aware of the recruitment of some Indian seamen in a British hospital ship that took part in the Falkland operation.

(b) Does not arise as the Indian seamen took up employment on their own accord.

- (b) if so. what is Government's reaction thereto as also to the arrest of political leaders such as Sarvashri C. N. Hussain, Abdul Khaliq Ansari, Abdul Qaiyum and Sardar Mohammad Ibrahim; and
- (c) what other details does the Government have in respect of the above?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI A. A. RAHIM): (a) Yes, Sir.

. (b) and (c) It i_s Government's hope that the people and the poutical leaders in Pakoccupied Kashmir would enjoy the same democratic rights as in the rest of India.

Meeting of nonaligned group

2478. SHRI MURLIDHAR CHAN DRAKANT BHANDARE: Will the

Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether the Non-aligned group of four-India, Cuba, Zambia and the PLO recently held an emergent meeting in the context of the Iranian troops having opened a new offensive along the Iran-Iraq border; and
- (b) if so, what specific issues were discussed therein and the outcome thereof?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI A. A. RAHIM): (a) Yes, Sir. The meeting was held in New York from October 1—3, 1982.

(b) The Ministerial committee reviewed developments in regard to the Iraq-Iran war and assessed the results of its activities and its several meetings with the Foreign Ministers of Iran and Iraq. There was general exchange of views amongst the four members of the committee in regard to the danger of further escalation of hostilities.

The Committee agreed to remain in close contact and reiterated that its efforts to bring about an early, just and peaceful settlement must continue.

Study of world financial economy

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS— SHRI A. A. RAHIM): (a) to (c) During the meeting of the Commonwealth Finance Ministers held in London in August 1982, it was agreed that in view of the vast politico-economic changes which had taken place since the establishment of the Bret-ton Woods institutions, there was a need for a new overall examination of the international trade and payments system as a whale and in particular the role of the international economic institutions. It was agreed that without prejudice to action to be taken on issues of immediate importance, such a study should be carried out by the Commonwealth Secretariat. We have concurred in the taking up of such a study. The Commonwealth Heads of Government Regional Meeting held in Suva from 14th to 18th October welcomed this decision and looked forward to the results of the study with great interest.
