Soviet offer to make Indian Ocean as a zone of peace

2490. SHRI N. P. CHENGALRAYA NAIDU; Will' the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether it is a fact that Soviet Union has offered to withdraw its war ships from the disputed area, of the Indian Ocean once the US dismantled its military base in Diego Garcia and retui'ned it to its rightful owner;
- so, whether the Indian Government has welcomed this move of U.S.S.R.; and
- (c) if so, what are the other con cessions USSR has agreed to provide to make the Indian Ocean as a Zone of Peace?

THE MINISTER OF STATE IN THE MINTSTRY OF EXTERNAL AFFAIRS (SHRI A. A. RAHIM): (a) to (c) No, Sir. In the Joint Statement issued at the end of the Prime Minister's visit to the USSR, how-ever, both India and the Soviet Union expressed their "great concern over the dangerous situation in the Indian Ocean" and called for "the dismantling of all foreign military and naval bases in the areas, for preventing the creation of new bases and condemned any attempt's to build up foreign military presence in the Indian Ooean". They also reiterated their support for "the just claim of Mauritian sovereignty over the Chago, archipelago, ' including Diego Garcia".

The Soviet Union has also supported the UN Declaration of a Zone of Peace in the Indian Ocean, and "the decision of the United Nations General Assembly to convene a Conference on the Indian Ocean in the first half of 1983. In his speech at the banquet in honour of the- Prime Minister, during her recent visit, the Soviet President broadly supported the position of India in regard to the Indian Ocean.

- (a) how many Indians have been killed or made prisoners during the recent war between Lebanon and Israel; and
- (b) what steps are being taken by Government for the release of Indian prisoners?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI A. A. RAHIM): (a) According to available information, 4 Indian nationals have been killed. The International Committee of tha Red Cross (ICRC) has intimated that 55 Indian nationals are presently under Israeli detention.

(b) The Government of India are in touch with the ICRC to secure release of the detained Indian nationals. According to the ICRC, these Indian nationals would be released within a few days, and arrangements are being' made for their return to India.
