Haldia ports port through Calcutta and and the details thereof?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI C. M. STEPHEN): (a) Yes. No iron ore was handled at Calcutta Port during the last five years. At Haldia Dock Complex also, the iron ore handling had declined.

(b) No ore is handled at Bombay Port. The details of iron ore handled at the ports of Calcutta, Madras, Paradip, Visakhapatnam and Mormugao during the Jast five years are as follows: -

(c) The iron or<sub>e</sub> is at present generally expected in bulk carriers of large size which neither Calcutta Port nor the Haldia Dock Complex is able to handle because of nonavailability of requisite draughts. As such, it is not possible to canalise any iron ore export through Calcutta. Even at Haldia, the transportation of iron ore has been completely stopped and only the existing stocks are being lifted to the extent possible.
