- (iii) Launching of massive programme for wheat-arhar rotation in the Northern States and involvement of Agricultural Universities and private sector in popularising this rotation in different States.
- (iv) Intensification of 'Lab-to-Land' Programme and pest management at the Village level.
- (v) Popularisation of cultivation of Arhar in rabi season in Eastern Plains of West Bengal, Bihar and Eastern Uttar Pradesh.
- (vi) Diversion of upland rainfed rice area_S in Bihar to Soyabean—Arhar Production,
- (vii) Strengthening of production of breeders'/foundation seed of improved varieties of pulses.
- (viii) Mas_s production of rhizobium culture strain_s with proper quality control.
- (ix) Testing of potentialties for new pulse crops like broad-tesns, rice-beans, moth etc.
- (x) Popularisation of rural storage of pulse by the farmers in optimum conditions so as to preserve the produce without damage.
- (xi) Adoption of 'Pulse Villages' by Private Sector in close collaboration with Government agencies.
- (c) Government has yet to examine the suggestions. However, work \mathbf{o}_n most of the suggestions brought out \mathbf{i}_n the Symposium, has already been in progress.

THE MINISTER OF STATE IN THE MINISTRIES OF AGRICULTURE AND RURAL DEVELOPMENT (SHRI R. V. SWAMINATHAN): (a) and (b). Many developing countries have approached the National Dairy Development Board in Gujarat for assistance in the field of dairying. assistance has been rendered for planning dairy projects and/or training officers from Mauritius, Sudan, Sri Lanka, Nepal, Bangla Desh, Bhutan, Afghanistan, Philippines Malaysia, Tanzania, Uganda, Trinidad and Tobago. At the request of the World Bank and European Economic Community, National Dairy Development Board's expertise in the field of dairy development has been provided Pakistan and Philippines respectively. Similar requests from Sri Lanka, Bangla Desh and Saudi Arabia have received by the National also been Dairy Development Board. At present, the nature of assistance provided by National Dairy Development Board is limited to manpower development and review of dairy sector and planning of dairy projects.
