A_s employment could not be given to all th_e concerned people, DDA decided to give weightage of 5 per cent marks in competitive examination. However, the matter was subsequently examined by the Delhi Administration in consultation with the Ministry of Home Affairs. 'It was found that giving such concession would be ultra vires of Article 16 of the Constitution and was therefore stopped.

As regards allotment of plots, 3191 residential plots were allotted to persons whose land was acquired. Information about the number of those left out is being ascertained.
