(b) All feasible steps will be taken to clear the extra rush of traffic before and after the Asian Games by way of running of special trains or by augmentation of coaches in existing trains based on the volume of traffic.

## Diversion of funds earmarked for conversion of Railway line

. JHA: Will the Minister of RAIL-WAYS be pleased to state:

- (a) whether it is a fact that the funds allotted for the conversion of the metre gauge into broad gauge lines from Samastipur to Darbhanga (NER) have been diverted to some other project;
- (b) if so, what are the reasons therefor

- (c) if not, what progress has been made in the conversion work so far in view of the fact that the inauguration of the conversion work was to be done by him sometime back; and
- (d) what progress has been made so far in the survey work of the Darbhanga-Jayanagar (NER) broadgauge conversion project, if no progress has been made the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) No.

- (b) Does not arise.
- (c) In view of the severe constraint of funds for construction of New Lines, it has not been possible to make any headway in the construction of the Sakri-Hasanpur new MG line, without which the MG system North of Darbhanga would get isolated if the Samastipur-Darbhanga section is also converted to B. G. This together with the fact that adefunds are not available for conversion schemes either, the work on the Samastipur-Darbhanga ject has not made any progress in the field.
- (d) The overall progress of survey work for conversion of Darbhanga-Jayanagar from metre gauge into broad gauge is about 15 per cent.
