- (a) whether it is a fact that a serious bus-train collision took place at a level crossing near Tarn Taran on the night of Saturday, the 11th September, 1982;
- (b) if so, the number of persons killed and injured in the accident; and
- (c) what were the causes of the accident?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) Yes.

- (b) In this accident, 34 persons were killed and 21 injured.
- (c) The Commissioner of Railway Safety, Lucknow has held a statutory inquiry into this accident. His report is awalted.

Investigation of Railway accident at Chandigarh

277. DR. SHANTI G. PATEL: Will the Minister of RAILWAYS be pleased to state:

- (a) whether the accident at the unmanned gate near Chandigarh involving several passengers of a bus have been investigated;
- (b) whether the earlier findings of the Railway Accident Committee with regard to the un-manned gates bas been implemented; and
- (c) if not what are the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIA-MENTARY AFFAIRS (SHRI MALLIKARJUN): (a) No accident involving a passenger bus and a train/engine at an unmanned level crossing near Chandigarh has been reported during 1982.

- (b) Recommendations of Railway Accidents Enquiry Committee-1978 (Sikri Committee) regarding unmanned gates generally pertain to framing of norms for manning of unmanned level crossings, utilisation of Railway Safety works Fund for manning, carrying out of traffic census, provision of speed breakers/bumps, etc. Action to implement these recommendations has been taken
