- (d) what is the number of recomnjfiR^ations implemented so far with detail thereof;
- (e) whether the Chairman of the Police Commission in a recent interview to a Bombay Weekly has stated that since not a sin/¹e recommendation of the Commission was implemented there have been police agitations in most of the States; and
- (f) whether Government propose to publi* the relevant reports?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR): (a) and (b) Yes, Sir. Eight.

- (c) and (d) A Statement is laid on the Table of the House.
- (e) No such statement of the Chairman in a Bombay Weekly has come to notice.
- (f) The First Report has been published and copies thereof laid on the Table of the House on 4th February, 1980. The question of publishing the remaining reports can be considered only after their examination is completed.
