(3) The Staff Artists of AIR and Doordarshan had requested for the grant of pension and treatment similar to those extended to regular-Government servants.	It has been decided that the Staff Artists should be divided into two categories (a) those performing functions similar to those discharged even now by regular Government servants and (b) Artists. Both the categories will be granted pension subject to their exercising options therefor and subject to their screening etc.
(4) The staff belonging to programme Cadre have requested for the formation of a separate Group A Service similar to Group A Service for the engineers.	Action has been taken to process this request.
(5) Guidelines should be laid down regarding transfer policy.	Transfer policy guidelines for the staff of AIR have been laid down in July, 1981.
(6) Timely action for filling up vacancies.	Instruction were issued that DPCs should be convened in time. In respect of posts in Gazetted and senior positions action was taken in time to obtain panels for vacancies expected upto the end of the current year. In many grades in engineering as well as in the programme and staff artists cadres, promotions have also been given effect to.

(d) The strength in the Doordarshan Kendra Delhi is 591 and in the Delhi Station of AIR 515. There are in all 86 Radio Stations and 20 Doordarshan Kendras including relay centres. The staff in the categories like engineering, administrative, programme cadres number over 15000. Posts in Groups 'C and 'D' as well as in certain Non-gazetted grades in Group B are within the recruitment competence of local authorities. Gazetted and senior posts are, however, filled up either by direct recruitment or by promotion by convening meetings of the Departmental Promotion Committees, as prescribed in the relevant recruitment rules. For posts in such positions requisitions were placed with the Union Public Service Commission and nominations were also obtained in respect of some grades. Similarly, panels recommended by the Departmental Promotion Committees for a number of grades have been obtained covering vacancies* upto the end of the year 1982 and promotions were given effect to as indicated against item (6) in the reply to part (b) above.

Plight of Quarry Workers

(a) whether Government's attention has been drawn to the plight of quarry workers around Delhi and other parts of the country as reported 'on Looker' (1—15 September, 1982);

(c) whether Government have any specific proposals under the Sixth or the Seventh Plans in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND REHABILITATION (SHRIMATI MOHSINA KIDWAI): The number of educated (Marticulates and above) and other job-seekers (of whom are not necessarily unemployed) on the Live Register of Employment Exchanges as at the end of 1979, 1980, 1981 and July, 1982 (latest available) was as under:—

* Information on the educated job-seekers is collected at half-yearly intervals as at the end of June and December each year—the latest available being as at the end of December 1981.

The information on job-seekers by rural and urban break up is being collected with effect from January, 1982 only. Out Of 186.6 lakhs of job-seekers at the end of July, 1982, as indicated above, 99.7 lakhs were from the rural areas and 86.9 lakhs from the urban areas.

Lockouts in Industries in West Bengal
