(d) if so, the action taken on those cases and outcome of such cases?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI I.D. SWAMI): (a) and (b) A number of incidents of recovery of fake Indian currency being pumped in by Pakistan have been noticed. During the last 3 years, 7 cases relating to fake Indian currency notes have been registered by the Central Bureau of Investigation.

(c) and (d) The Government of Bihar has requested for transfer of one case relating to fake currency notes to CBI for investigation. Action will be taken by CBI after requisite notification and formal registration of the case.

Viability of NTC Mills

†*336. SHRI KRIPAL PARMAR: Will the Minister of TEXTILES be pleased to state:

(a) the number of the units of the National Textiles Corporation which are engaged in production together with the number of closed units;

(b) the year-wise details of the profits/losses suffered by each of the unit during the last three years together with the location of these units;

(c) the reasons for losses suffered; and

(d) the steps taken/proposed to be taken by the Government to make them viable?

THE MINISTER OF TEXTILES (SHRI KASHIRAM RANA):

(a) Out of 119 mills of National Textiles Corporation (NTC)

there is no production activity in 43 mills. No NTC mill has been closed except Ajudhia Textile Mill which was closed in 1996 in compliance of Supreme Court's order on polluting industries.

(b) The details of profit earned/loss suffered by each of the NTC mills during the last 3 years and their locations are given in Statement (See below).

(c) The mills working under NTC were taken over by Government from private sector and were amongst the weakest in the Industry. Most of these had been running in losses and some of them were lying closed even before the takeover. The main reasons for continuous losses by NTC mills are:—

- Old and obsolete machinery
- Lack of Modernisation
- Excess labour force
- Acute shortage of working capital

(d) The Government's approach and efforts are for revival of the maximum number of these mills as per BIFR norms of net worth turning positive within the stipulated period through resources to be generated by sale of surplus land and assets of these mills.
