Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether Government's attention has been drawn to a report appearing in 'Hindustan Times' of

12-9-82 to the effect that a woman intern was refused leave even without pay and put on a 12-hour duty for two days after she aborted a seven week old foetus in the Lady Hardinge Medical College, New Delhi;

(b) whether it is a fact that on the second day (5-9-82) while doing a caesarian section she fainted on the operation theatre and has been hospitalised since 7-9-82;

(c) if so, details thereof; and

(d) whether Government have conducted any enquiry and what action has been taken for such inhuman behaviour on the part of officials concerned ?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHANKARANAND): (a) to (c) With reference to the report published in the 'Hindustan Times' dated 12th September, 1982, it is stated that the intern concerned did not inform on 5-9-82 that she had high fever. She did not faint in the operation theatre that day. She attended to her duties in the hospital on 6-9-82. However, she did not report for duty on 7-9-82. She was admitted in the hospital on 8-9-82 in the Medical Ward, with a complaint of Pyrexia, which was diagnosed and treated successfully as enteric fever.

(d) The matter has been looked into. The intern concerned was granted leave whenever the same was applied for. There has been no instance of inhuman behaviour on the part of any of the officials of the hospital.
