THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN) : (a) There is no such proposal at present.

### **Construction of Railway line from Trivandrum to Punalur**

853. SHRI K. MOHANAN : Will the Minister of RAILWAYS be pleased to state :

(a) whether Government have received any memorandum from Dakshin Railway Employees Union regarding the construction of a broad gauge railway line from Trivandrum to Punalur via Nedumangad in Kerala ; and

(b) if so, what is the present stage of the proposal and whether any scheme in this regard has been prepared ?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN) : (a) Several representations for construction of a broad gauge line from Trivandrum to Punalur were received from different sources.

(b) There is no proposal at present for construction of this line.

### **Laying of railway lines in backward areas of Rajasthan and Madhya Pradesh**

854. SHRI BHUVNESH CHATURVEDI : Will the Minister of RAILWAYS be pleased to state :

(a) whether a preliminary survey for Railway line linking Kota and Jhalawar in Rajasthan and Agra and

Ujjain in Madhya Pradesh was ever made by Government ; and

(b) whether there is any proposal under Government's consideration to lay railway lines in this backward region comprising these parts of Rajasthan and Madhya Pradesh ?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN) : (a) and (b) No survey has been carried out for linking Kota and Jhalawar. As regards link between Agra and Ujjain, presumably, reference is to the link between and Agra in Madhya Pradesh. There was an NG line linking these places, which has since been dismantled. No survey has subsequently been carried out for construction of this link.

### **De-reservation of posts in Railways**

855. SHRI H. HANUMANTHA-PPA : Will the Minister of RAILWAYS be pleased to state :

(a) the number of posts which have been dereserved in each category ;

(b) what are the reasons for such dereservation ;

(c) what is the procedure followed in dereserving the posts ; and

(d) whether Railways propose to ban the dereservation ?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN) : (a) Information pertaining to the year 1980-81 and 1981-82 is being collected and will be laid on the Table of the Sabha :

(b) De-reservation is resorted to when Scheduled Caste/Scheduled

Tribe candidates are not available and/or are not found suitable despite allowing them relaxations and concessions as per the extent policy.

(c) Dereservation is resorted to when a suitable person from the community in whose favour a vacancy has been reserved is not available to fill it up. No reserved vacancy can be filled up by a person other than from the reserved community before it is dereserved.

Proposals for dereservation of reserved vacancies to be filled by recruitment/promotion are processed by the recruiting authority. The dereservation is done with the approval of the prescribed competent authority and the vacancy reserved is carried forward. In the subsequent year, if the candidates from reserved community are available, the vacancies which are carried forward are filled up by them; otherwise such vacancies are carried over for two more recruitment years at the end of which exchange between Scheduled Caste/Schedule Tribe candidates is made and shortfall is wiped out.

#### **Demand for wagons for the movement of coal**

(c) if so, whether it is due to non supply of coal by Coal India Ltd. or non-purchase of adequate quantities by the railways or be-

cause of inability of the railways to move coal for its own requirements?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) Yes.
