Agitation by Delhi University Karamchari*

Will the Minister of EDUCATION AND CULTURE be pleased to state:

(a) what aie die demands for which Delhi University Karma-charis are carrying on their agitation;

(b) whetiier non-implementation of earlier commitments made to then is responsible for the agitation; and

(c) if so, what steps have been taken for die implementation diere of?

THE MINISTER OF STATE IN THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WELFARE (SHRIMATI SHEILA KAUL) : (a) to (c) According to the agreement signed between die Delhi University and the Ka-rmacharis Union, the University had agreed to examine in consultation widi the appropriate authorities, where necessary, the introduction of a time-bound promotion scheme for non-teaching employees, payment of 20% bonus to die employees of die University Press, «on«*ru ction of a School building

in die Campus; construction of quarters for low-paid employees; establishment of a machinery for setdement of grievances; and reexamination of die question of dfecrimination in regard to 'no work no pay' between teachers and Ka-rmacharis during absence from duty.

Bonus is payable only if diere are profits; during die current year die press had incurred a loss and no bonus was paid. The plans and estimates for die construction of die Social Centre School in the Campus are under finalisation. Committees have been set up to consider grievances of employees and die specific question of discrimination between teachers and Karamchand in respect of 'no work no pay'.

The remaining items of die agreement, namely promotion scheme, staff quarterSj and other service conditions require approval of the UGC as they are also applicable to odier Central Universities. The Commission has already appointed a Committee to identify any disparity or distortion in die existing scales of of pay and promotion Schemes in different Central Universities . The question of formulating a Scheme for promotion of non-teaching employees has to be considered after diis Committee has submitted its findings. As for staff quarters, die Commission has been considering the possibility of raising adequate resources in die form of loans, etc. from agencies like LIC, HUDCO, etc. More recendy, a scheme for raising a loan against Provident Fund Investments formulated by die University has been submitted to the Government by die Commission for consideration.

The representatives ofthe Union were apprised of the various steps taken by die University from time to time to implement the agreement. The agreement also provided that in future die Union will ensure diat all

its problems would be resolved through peaceful negotiations. Notwithstanding these assurances; the Delhi University Karamcharis have launched the current agitation.
