- (a) whether it is a fact that a cook ing gas agency at Bhopal reserved for tribals has been allotted to the son of the Deputy Chief Minister of Madhya Pradesh;

- (c) what is the quota reserved for tribals and whether there has been any such diversion before this also; and
- (d) whether any action is being taken by Government in the matter to compensate the tribals?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI DALBIR SINGH): (a) Shri Suraj Bhan Solanki, a candidate belonging to Scheduled Tribe has been selected for this agency, reserved for Scheduled Tribe. He happens to be the son of the present Deputy Chief Minister.

- (b) The selection was made in line with tho policy-laid down for the pur pose.
- (c) 25 per cent of aU petroleum product dealerships/distributorships are reserved for persons belonging to SC/ST communities. In the instant case Ithere has been n_0 deviation from policy inasmuch as the person selected for Bhopal Cooking Gas Agency earmar ked for "ST* category reportedly be longs to ST Community.
- (d) Does not arise in view of (c) above.
