For this purpose, Government has decided to use various modes of transmission like terrestrial transmitters and direct reception through satellite. High power transmitters will be used for big cities and areas having large concentration of population while low power transmitters will serve the needs of sparsely populated, hilly and remote areas. Direct Reception Sets capable of receiving programmes directly from satellite would cater to the needs of villages in isolated and farflung areas. The INSAT Scheme 18 mainly for providing coverage for rural and economically backward areas.

### Social National Education Programmes on Television
