Small scale industries in States

2773. PROF. M.M. AGARWAL: Will the Minister of SMALL SCALE INDUSTRIES AND AGRO AND RURAL INDUSTRIES be pleased to state:

- (a) the number of small scale industries units functioning in the State of Uttar Pradesh, Delhi, Rajasthan, Madhya Pradesh, Orissa at present;
- (b) the present status of the above units with regard to sickness and unemployment in these States;
 - (c) the details of reasons therefor; and
- (d) the steps being taken or proposed to be taken by Government in this regard?

THE MINISTER OF STATE OF THE MINISTRY OF SMALL SCALE INDUSTRIES AND AGRO AND RURAL INDUSTRIES (SHRIMATI VASUNDHARA RAJE): (a) The estimated number of registered small scale industrial units as on 31.3.2000 is given below:

As regards unemployment in these units, State-wise, the information is not maintained by RBI. The main reasons for sickness are inadequacy of credit, technological problems, marketing problems, infrastructural constraints, faulty planning, managerial deficiences etc.

(d) The Government has taken various measures to facilitate timely identification and rehabilitation of potentially viable sick SSI units. These inter alia include institutional mechanism in the form of State Level Inter-Institutional Committee (SLIIC), Sub-committee of SLIIC and Sick Units Rehabilitation Committee at the district level, special rehabilitation cells in Banks and State Financial Institutions to co-ordinate and facilitate rehabilitation of sick SSI units. The RBI has issued guidelines to the banks for rehabilitation of potentially viable sick SSI units and detect sickness at the incipient stage for taking remedial measures. The RBI has also advised the banks on the broad parameters for grant of relief and concessions like lower rate of interest on working capital, working capital term loan and interest free Funded Interest Term Loan etc. for revival of potentially viable sick units. On 27th July 2000, the RBI has also announced a scheme of one time settlement for the sick industrial units including SSI units.
