- (i) Stone: Rs. 12/- per truck of 5M3 plus sales tax.
- (ii) Badarpur Sand: Rs. 26/- per truck of 5M3 plus sales tax.
- (iii) River Sand: Rs. 26/- per truck of 5M3 plus sales tax.
- (d) DSIDC is not contributing to the increases in prices of these minerals.

THE MINISTER OF STATE IN THE MINISTRIES OF INDUSTRY STEEL AND MINES (SHRIMATI RAM DULARI SINHA) (a) to (c) According to information received from the Maharashtra State Mining Corporation, operations in the stone quarry known as Shelgi Trapstone Mine in Sholapur district was suspended for some time due to operational difficulties but is now under operation. The Maharashtra State Mining Corporation are reported to have fourteen mining leases of which 4 are being worked, one is still to start and the remaining mine have been closed due to uneconomic working condition.

# Technical Director, NALCO

- (c) and (d) No, Sir. According to the present policy of Government a sitting Member of Parliament should not as a rule be appointed as a part-time Director on the Board of Directors of central government enterprises.

- (d) The Company has one Secretary.
- (e) The Registered Office of the Company is already operating from Bhubaneswar, while a Liaison office is situated at Delhi.
