- (d) how Government propose to utilise the total production of 11.34 lakh tonnes of caustic soda against the anticipated demand of 7 lakh tonnes in 1984?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI P. SHIV SHANKAR): (a) There is no statutory control over the distribution of Caustic Soda.

- (b) and (c) The production caustic soda during January to March, 1981 was 1.46 lakh tonnes. The production of Caustic Soda during January to March, 1982 was 1.46 lakh tonnes. The stock of caustic soda with the manufacturers during January to March, 1981 was 0.14 lakh tonnes. The stock during the above mentioned period in 1982 was 0.19 lakh tonnes. The installed capacity of caustic soda during 1981 was 7.79 lakh tonnes. The installed capacity in 1982 is 8.16 lakh tonnes. Hence it cannot be said that there has been fall in the substantial off-take of caustic soda during the first quarter of 1982.
- (d) The Working Group on Inorganic Chemicals comprising of the Members from the DGTD, the Planning Commission, the Development Commissioner, Small Scale Industries and the Deptt. of Chemicals and Fertilizers have estimated the demand during 1984-85 to be 8.50 lakh tonnes against an anticipated production of 8.50 lakh tonnes.

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI P. SHIV SHANKAR): (a) The Selection Committee evaluates the eligible candidates on the basis of business ability/salesmanship, capacity to arrange finance and capability to provide facilities, ability as full time working dealer, general assessment, personality and extra-curricular activities.

- (b) The Selection Committee, for selection of dealers under 'open' category consist of one representative of the concerned oil company and a representative each of two other oil companies. For selection of dealers under reserved categories, the committee also has a representative from the Government. However, for selection of SC/ST candidates applying against advertisements issued 1_10-1981, the Selection Committee in addition to the Government of India's representative consists of a representative of the concerned State Government not below the rank of Deputy Secretary. Names of the members of the Selection Committees vary from location to location and are not readily available unless specific locations are indicated.
- (c) Since (their) relationship with IAS officers and political leaders is not ascertained from the applicants for dealerships, this information is not available.
