MINISTER OF STATE THE MINISTRY OF PETROLEUM, THE CHEMICALS AND FERTILIZERS (SHRI DALBIR SINGH): (a) The classification of the technology manufacture of bulk drugs was made by the High Technology Committee for the purpose of identifying foreign companies engaged in the manufacture of bulk drugs not involving high technology for determining the permissible level of foreign equity under FERA and for future licensing under Drug Policy.
