

(x) Sole selling agencies for drugs and formulations (except for exports) have been abolished by a Notification of the Company Law Board.

(f) the number of Divisional officers of the Indian Oil Corporation in Assam and the North-Eastern Region?

#### Manufacture of life Saving Drugs

1981. SHRI SYED SHAHABUDDIN: DR. SARUP SINGH:

Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to state:

(a) the names of major anti-biotic

and life saving drugs which are not yet manufactured in the country or are manufactured in insufficient quantities;

(b) whether Government have plans to manufacture such drugs or to increase their production progressively; and

(c) the names of firms which have applied for licence for manufacturing these drugs?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHR DALBIR SINGH): (a) Some of the important and essential drugs which are not yet manufactured in the country or are manufactured in insufficient quantities are Chloramphenicol, Semi-Synthetic Penicillins, Rifampicin, Chloroquin, Methyl Dopa, Aminophylline and Theophylline.

(b) Yes, Sir.

(c) The only application for the manufacture of the drugs mentioned above on which a decision is yet to be taken is from M/s. Ciba-Geigy of (India) Limited for the manufacture of Rifampicin.
