No person has been selected and sent on such assignments consecutively for the last 1hree years.

## Pay Scales of Army Jawans

of Jawans are not comparable with-those of industrial workers. Pay scales of Jawans were revised with effect from January 1, 1973 in such a manner as to give him an edge corresponding personnel in paramilitary forces.

- (b) Although the pay scales of Jawans Were not revised thereafter, their service conditions have been made more attractive by various measures mentioned below:
  - (i) Dearness Allowance and City Compensatory Allowance are now paid at par with civilians instead of at 80 per cent of the sanctioned rate, as was the case earlier
  - (ii) High Altitude/Uncongenial Climate Allowance in difficult hilly areas and Special Compensatory Allowance have been increased.
  - (iii) Admissibility and authorisation of compensation in lieu of quarters (CILO) have been liberalised.
  - (iv) Insurance cover fot Jawans under the Army Group Insurance Scheme has been increased from Rs. 30.000/- to Rs.
  - (v) Improvements have also been made in {he promotional opportunities for Jawans. Also, two new Honorary Ranks, viz. Honorary Havildars and Honorary Naiks, have been introduced.
  - (vi) Entitlement of encashment of leave preparatory to retirement has been increased from 90 days to 120 days.
  - (vii) Considerable improvement has also been made in their pensionary benefits by merging a portion of Dearness Allowance with pay for retirement benefits and by introducing a new slab system for assessment of pension.
