

(b) whether it is also a fact that the condition of runway pavements and other buildings has deteriorated because of lack of maintenance;

(c) if so, what steps have been taken by Government to repair the airport pavements and for development of terminal facilities; and

(d) what is the estimated cost for all the works and what is the provision made for civil works during the Sixth Five Year Plan period in this regard?

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI A. P. SHAR-MA):

(a) and (b). Yes, Sir. The aerodrome has not been in use for a long time. The deterioration in the condition of pavements and buildings is due to normal wear and tear. The maintenance of this aerodrome is not as intensive as that of an active aerodrome.

(c) and (d). To reactivate the aerodrome, the pavements and terminal building are to be developed and safety services and radio, navigational and communication facilities are to be provided. The rough cost estimate of all these works

will be Rs. 115.16 lakhs. A provision of Rs. 50 lakh for civil works has been made in the Sixth Five Year Plan (1980—85).

(a) whether it is a fact that the price of gold in the world market has been steadily going down;

(b) if so, what was the price of gold in the world market on the first of every quarter beginning from January, 1981;

(c) whether it is a fact that contrary to the world trend the internal price of gold has been relatively stable;

(d) if so, what has been the price of gold in the Indian market on the first of every quarter beginning from January, 1981;

(e) whether this phenomenon has resulted in large scale smuggling of gold into India; and

(f) if so, what is the quantum of gold estimated to have been smuggled during each quarter beginning from January, 1980?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SAWAI SINGH SISODIA): (a) and (c). Yes, Sir

(b) and (d). The international and domestic price of gold on the first avail-

able date of each quarter beginning from January, 1981 is given below;

(f) There is no authoritative estimate of the quantity of gold smuggled during each quarter beginning from January, 1980. However, the quantity of gold seized by the Customs authorities while being attempted to be smuggled during the period 1980 to 1982 (upto May) is given below:—
