Financial crisis faced by Sugar Mills

(b) if so. what steps Government propose to take to ease the financial crisis faced by the sugar mills?

THE DEPUTY MINISTER IN THE MINISTRIES OF AGRICULTURE AND RURAL DEVELOPMENT (MISS KAMLA KTJMARI): (a) and (b) The problems of inadequate credit arising out of the record production of sugar and the accumulation of stocks were brought to the Notice of the Government. To meet the situation, the Reserve Bank of India enhanced the credit limits of the sugar factories to 125 per cent of their last year's peak level drawings, in addition, individual cases for grant of still further bank credit ar_e also . considered on merits.

Collection of cash from Milk Depots.
