Ten Plus two System

2325. SHRI BHUVNESH CHATUR-VEDI: Will the Minister of EDUCATION be pleased to state:

(a) the names of the States which have introduced ten plus two system of education;

(b) the names of the States which have so far not introduced the above-mentioned system; and

(c) what steps Government propose to take with regard to those States which have not opted for the above-mentioned system?

THE MINISTER OF STATE IN THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WELFARE (SHRIMATI SHIELA KAUL): (a) and (b). Excepting the States of Haryana, Himachal Pradesh, Madhya Pradesh, Meghalaya, Punjab, Rajasthan and Uttar Pradesh and the Union Territory of Mizoram, all the States and Union Territory have switched over to the 10 + 2 system of school education.

(c) These States/Union Territories have agreed, in principle, to switch over to the 10 - 2 system of school

education. Government is constantly persuading them to switch over to the new system at the earliest.

(d) whether it is a fact that the building of the school, though complete, has not so far been handed over to the school; if so, the reasons therefor;

(e) whether the students are getting education in tents where rain water is logged;

(f) what is the number of teachers in the school at present; and
