of the country for their beautification; and

(b) what other steps are proposed to be taken to increase the tourist potentialities of the lakes having national importance?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI) KHURSHED ALAM KHAN): (a No, Sir.

(b) There is no proposal under Government's consideration for the development of lakes *perse* in the country as places are developed on the basis of their tourist attractions or the potential they hold to attract tourists. However the lakes of national importance included for the travel circuits development in which have been indentified for tourism development are Pulicar, Pakhal wildlife Lake and sanctuary, Sibsagar, Tilaiya, Suraj Kund, Badkal, Thekkady, Loktak, Chilka, Pushkar and Ukai.

Visit by ITDC Officer to *the* 'Festival of India, London'

Operation of Cars by ITDC without Permits

- fa) whether it is a fact that more than 14 cars were operated in the Delhi Transport Unit of the ITDC without permits and payment of taxes as revealed in a "strictly confidential" ITDC Letter No. T/Permit/701, dated 1st July, 1982 addressed to the Regional Manager (North) which was published in the Statesman, Delhi Edition dated the 10th July, 1982;
- (b) if so, what are the details of tax evasion involved in this case and the reasons for which the cars were permitted to operate without permits by the Delhi State Transport Authority; and
- (c) what action Government propose to take against the ITDC in to matter?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI KHURSHED ALAM KHAN): (a) The information is not well-founded.

(b) A news item under the caption "Tax Evasion by ITDC overlooked" appeared in the Press. A rebuttal was published in the Press by the ITDC. *I* he taxes in respect of ITDC vehicles were paid to the RTO, Varanasi

and STA, Lucknow. The Delhi STA was, however, not aware of the fact about the transfer of the vehicles. The position was explained to the STA Delhi to their satisfaction.
