Mobile Health Units

2730. SHRI JAGDISH JANI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether Government have Mobile Health Units in the backward and hilly districts of various States;
 (b) if so, whether some Mobile Health Units have been set up in Phulbani a backward and hilly district of Orissa; and
 (c) what are the details of the locations of those Mobile Health Units functioning in Orissa?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (MISS KUMUD BEN M. JOSHI): (a) to (c). The Government of India do not have any scheme for the establishment of Mobile Health Units in the States. However, under the Reorientation of Medical Education Scheme, the Government of India have provided 3 specially designed and equipped mobile clinics to each medical college of modern medicine, free of cost, to improve the quality of health services in the areas covered by the Primary Health attached to each medical college, for the community orientation of medical students.

Primary Health Centre, in Orissa

2731. SHRI JAGDISH JANI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether it is a fact that some Primary Health Centres have been set up in Orissa under the N.R.E.P. Programme;
 (b) if so, the number of Centres that have been set up in different districts of Orissa in the last two years;
 (c) whether some more centres are proposed to be set up in 1982-83 in

different districts of Orissa under the above programme; and

- (d) if so, the details about their location?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (MISS KUMUD BEN M. JOSHI): (a) to (d). Primary Health Centres are not set-up under the N.R.E.P. However, according to available information three Primary Health Centres were established in Orissa during the last two years under the Health Sector Minimum Needs Programme. The State Government proposes to establish three new Primary Health Centres during 1982-83. The location of these Centres shall be decided by the State Government.
