Balipara to Bhalukpong in Arunachal Pradesh; Amguri to Tuli in Nagaland; and Lalaghat to Bhairabi in Mizoram. These will be completed. Apart from that, there are some bridges also we have to take up, for instance, in Jogigoppa and Tejpur, and so on. The Government is keen to see that these are completed at the earliest possible time so that facilities for industrialisation can be created in this whole region which was suffering for want of development.

DR. (SHRIMATI) NAJMA HEP-TULLA: I think the hon. Minister for giving an elaborate answer. But I was only asking for the ratio in relation to the dotal railway lines in India.

SHRI MALLIKARJUN: Ratio is almost zero because these are new lines connecting those places which have not been linked with railway lines so far. And, Sir, in Assam, from Gauhati we are taking up only now and, therefore, the ratio will be only zero in comparision to the overall length.
